

## FREQUENTLY ASKED QUESTIONS

### ***What are the HEC-EC/ECSE entrance requirements?***

All applicants need to have a minimum of a bachelor's degree in a liberal arts area. The HEC-EC/ECSE courses are graduate level courses.

Licensed educators may use the courses to add either the early childhood educator (birth—grade 3) or the early childhood special educator endorsement. For individuals who do not possess an educator license, the courses may be used in conjunction with the Peer Review process; support for these students will be provided.

### ***Is any financial support available to individuals?***

No, unfortunately we do not have any financial support available at this time.

### ***How do I apply to the program?***

### ***Will my previous courses count towards licensure?***

Possibly. Courses that are comparable to the HEC-EC/ECSE courses may be considered in lieu of any required course. Documentation can be submitted to the program coordinator for review.

### ***Can I begin now?***

The new cohort begins in June 2013. You may apply at any time to enroll to take the entire sequence of courses, or to take any course offered. There is a separate application process if you'd like to apply to LSC to complete the masters degree.

The goal of the Higher Education Collaborative—Early Childhood/Early Childhood Special Educator (HEC-EC/ECSE) licensure programs is to increase the number of licensed educators in these fields. These programs are specifically designed to be accessible and affordable for educators who are currently employed on a full-time basis. Courses are provided on-site, online, or through a combination of both delivery methods. In order to build a peer support system, these programs use a cohort model.

### **Features of HEC-EC/ECSE:**

- Graduate level Lyndon State College courses
- Courses fulfill requirements to add an ECE or ECSE Endorsement
- Licensure coursework lays the foundation for a masters degree in education.

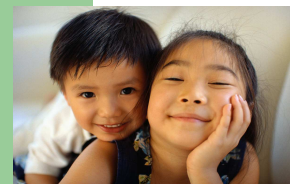

**Early Childhood Educator

The Early Childhood Educator licensure program is an 18-credit graduate level program. The sequence of courses appears in the next panel.

Through an agreement with Lyndon State College, participants have the OPTION to continue beyond the courses and credits needed for licensure, and apply their work towards a master's degree in Education.

**Early Childhood Special Educator  
Licensure Program**

The Early Childhood Special Educator licensure program is a 21-credit graduate level program. The sequence of courses appears in the next panel. As you'll notice, there is an overlap with some of the Early Educator courses.

This program also has an agreement with Lyndon State College such that participants have the OPTION to apply these courses towards a master's degree in Education.
